My endeavor is to return to the home of **Savera Begum**, a female citizen of Bangladesh living in the shelter home of Bihar for the last four years.

In this poignant case, the Government of Bangladesh not only praised my humanitarian work but also entrusted me with the important responsibility of return of Savera Begum.

Bangladesh High Commission has also provided me the travel permit of Savera Begum. The letter addressed in my name by the Bangladesh High Commission has been sent to Secretary, Foreign Ministry (MEA), Secretary, Home Ministry (MHA) and other key officers and departments.

It is a matter of great pride for me and our organization Human Rights Umbrella Foundation and no less than any big award/honor. **The media also gave prominence to this matter.**

12 SEPTEMBER, 2019 - THE MOST SPECTACULAR, GLORIOUS, MEMORABLE, POIGNANT AND HISTORICAL ACHIEVEMENT OF MY LIFE SO FAR!

Satish Chaudhary, mentally ill of a poor family of Darbhanga, Bihar, imprisoned for the last 11 years in Bangladesh jail, got me back in 40 days, (12 Sep, 2019) due to my tireless efforts.

It was a very touching case. For the last 11 years, Satish Chaudhary's wife had almost stopped speaking in the disconnection of her husband. In 2008, his younger brother Mukesh stumbled from year to year to find his elder brother Satish who had disappeared from Patna.

In the year 2012, Mukesh meets Bihar Chief Minister Nitish Kumar in his 'Janata Darbar', so that his elder brother Satish could be repatriated from Bangladesh jail. **But he did not get any help from the level of Chief Minister of Bihar ?**

He tried his best to get his brother back from Bangladesh everywhere, but the result was zero!

Then after losing tired, in the last week of July last year (2019), he sent me a sad application for help. And I worked at war level and got Satish back from Bangladesh jail in just 40 days.

Bangladesh Border Guards gave me a grand welcome on the direction of Bangladesh Government for this historic humanitarian work on India- Bangladesh Border.

Returning the lost happiness of a poor family and the smile on their faces after 11 years. I got immense peace and happiness. This happiness was like getting '**Bharat Ratna Award**'. Human Rights Umbrella Foundation played a big role as an NGO in Satish Chaudhary's return from Bangladesh. **Print and Electronic media of the country and abroad gave much importance to this historical work of humanity done by me and our organization Human Rights Umbrella Foundation.**

3 5 DECEMBER, 2019 - ANOTHER SUCCESSFUL BANGLADESH MISSION!

I worked tirelessly to get the mentally ill **Anil Kumar Singh** of Ballia, Uttar Pradesh released from Bangladesh Jail. After the release of Satish Chaudhary of Darbhanga in Bihar from Bangladesh jail on 12 September, 2019, Anil Kumar Singh's younger brother Sunil Kumar Singh sent an application to me and requested for help.

In this poignant case, the High Commission of India based in Dhaka, Bangladesh cooperated best and handed it from Aeroplane from Dhaka to Indira Gandhi International Airport in New Delhi.

This was a memorable and magnificent work done by me and our organization Human Rights Umbrella Foundation for humanity.
